

PURE KICK FORZA MOTORSPORT AND FAMILY DOLLAR SWEEPSTAKES

OFFICIAL RULES (the "Official Rules")

NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD / PURCHASE PERIOD: The Pure Kick Forza Motorsport and Family Dollar Sweepstakes (the "Sweepstakes") begins at 12:00:00 AM US Pacific Time ("PT") on May 1, 2025, and ends at 11:59:59 PM PT on September 7, 2025 (the "Sweepstakes Period"). To enter with a purchase, purchase must be made between May 1, 2025 at 12:00:00 AM PT and August 31, 2025 at 11:59:59 PM PT (the "Purchase Period"). The computer clock of the Administrator is the official time-keeping device in the Sweepstakes. By participating, participants ("Participants") agree to be bound by these Official Rules and the decisions of The Jel Sert Company (the "Sponsor"), which are binding and final on matters relating to this Sweepstakes.

ELIGIBILITY: Sweepstakes is open only to legal residents of the fifty (50) United States and District of Columbia (NOT including residents of Puerto Rico, Guam, or other U.S. Territories), who are at least eighteen (18) years of age or the age of majority in their state of primary residence (whichever is older) at time of Sweepstakes Entry. Visit www.activaterewards.com/purekick (the "Website"), select the option to confirm you made a participating product purchase at Family Dollar during the Purchase Period, submit an image of your full receipt for in-store purchases, or a screenshot of your shipping, pickup or delivery confirmation for online purchases, with qualifying item(s) starred, on the Website by September 7, 2025, for validation. Submissions are reviewed within 2-5 business days. Once your receipt has been validated, you will receive an email confirming your entry into the Sweepstakes. For each validated receipt submission, you will receive one (1) Purchase Entry. **2) Alternate Means of Entry:** To receive one (1) entry without making a purchase ("AMOE Entry", together with Purchase Entries, "Sweepstakes Entries"), visit purekick.entertowinprizes.com (the "AMOE Website"), and complete and submit the online form during the Sweepstakes Period to receive one entry into the Sweepstakes.

Sweepstakes Entries generated by script, macro or other automated means, and Sweepstakes Entries by any means which subvert the entry process, are void.
